Expanding to Projects and Products

- Frictionless Cost Accounting (aka Frictionless Time)
 - Mobile Time for FCA Tasks and Populate with ETC
 - Time Entries indicate Method (Automated vs Manual)
 - Auto-submit Timesheets
 - Auto-approve Timesheets
- Link 'Rally Formatted ID' to Rally Portfolio Items

Customer Voice

- Resolve Auto-Refresh issues for Properties and Details***
- Enhanced Tasks grid
 - "Expandable tree grid and filtering, including the 'Copy from..." action
 - "Has Dependencies" attribute added to the Task object
 - Dependent Task Status, Start and Finish added to the Task Details flyout



Customer Voice

- Update % Complete: 'Include Milestones when Updating Task Status' Option
- View Option to 'Show Items on Separate Rows' in Timelines of Roadmap Groups
- Turn off Classic URLs (while still allowing channels to Classic to work)
- Assignment object for Labels and FLS
- Add Multi-Valued indicator to Attributes grid for Lookups and Attachments
- Certify Clarity with MSP 2021 and 2024



Providing Financial Transparency

- Multi-Currency Conversion upon sync in Roadmaps
- Edit Groupings on Existing Cost Plan Detail Rows***
- Business Rules: Financial Cost/Budget/Benefit Plans and Details
- Source on Cost Plan Detail rows



Business Intelligence (Including Foundations for Future Insights) GA

- Reports Library, including Logs in Details flyout
- Export reports to PPTX improvements
- Export to PDF
- Email report output
- Notify of status for scheduled reports
- Data extraction report type



Data Providers and Data Warehouse

- Time entries by day (via a SQL Curve for Time Entry Actuals)
- Agreements w predecessors and successors
- 'Is Empty/Not Empty' lookup and Dependent lookup support



Reports Designer

- Report-level saved filters
- Report-level required filters and ability for viewer to add/remove filters
- OBS Tree in Filters
- OOL for Styles and Density for Attribute Groups, Tables, and Charts
- Drag-and-drop widgets onto the canvas
- Text, link, image, and line widgets
- Drill Down Reports
- Colors in Pie/Donut/Column/Bar Charts based on Display Mappings
- Group By and 'Auto Expand Groups' & 'Show Group Counts' Option for Tables
- Row (versus Column) orientation of per-period metrics in Grids
- Icons in column panel (e.g., to indicate data type)
